	emphasize the benefits and value of interoperability: quality and efficiency. "Meaningful Use" is very important, but the real-life benefits of improved workflow will be emphasized in the showcase. The group also discussed how to prepare for future phases of "Meaningful Use" by addressing structured documents such as CDA. There is much education needed for the group to get up to speed on these types of documents. Other IHE Domains have undertaken developing structured reports, e.g., Radiology, Patient Care Coordination. The group thought that a meeting in September would be appropriate for planning for the 2010-2011 cycle. An appropriate topic to consider for 2010-11 might be the evaluation of such structured documents and options, with presentations by HL7 and IHTSDO. A longer meeting format might be needed in September.		
3.	The group discussed the educational piece for physicians, administrators, IT and procurement staff. This should take different parts of the Technical Framework (Workflow and its major elements – MWL, MPPS, SC, Charge Posting, Displayable Reports, Evidence Documents) and explain the main features for each part: - This is what IHE says - This is what it means to your practice - What you should specify in an RFP in order to gain this functionality This needs to be presented to make it simple for people to understand. 4.	The group also discussed an outline of an article presented by Alan Golota. Alan explained that this could be the format for the topics a reporter could ask a clinician about IHE Eye Care. The group reviewed the outline. The group thought this was a good outline for the description of IHE Eye Care; however this had been tried in the past and physicians don't seem to be interested in the theoretical/details. The physicians would be more interested in how it directly impacts their practice. The group learned that there are now success stories with partial implementations of IHE. There will be an article appearing in Ophthalmology Management about an implementation in July 2010. The group agreed that these should be encouraged and highlighted at the Showcase, with posters and handouts. There is a template for Cleveland Clinic that the group agreed would be a good format for the IHE Eye Care success stories. Flora will send it around to the group. Medflow, Ophthalmic Tools and Carl Zeiss Meditec were three vendors who had success stories that could be developed into posters and handouts for the Showcase. These should be provided to Flora before the end of August for production, and Flora will ensure that these are appropriate for the audience and not overly vendor-focused.
