#### **Technical Committee: Change proposals (CPs)**

7 CPs from FM (GMSIH) were reviewed

CP1: Inconsistencies in transaction PAT-3 (Order Results Management). Accepted by JCC (**Person assigned**: **JCC**)

CP2: Inconsistencies in transaction PAT-2 – Filler Order Management. Accepted by JCC (**Person assigned: JCC**)

CP3: acknowledgement rules defined in ITI TF. Everybody agreed that acknowledgement rules should not be defined according to ITI TF section 2 vol2 (Appendix C.2.3). (**Person assigned: RG (Satec)**)

CP4: Image Display Actor. This actor is part of the collaboration diagram but is not defined in the Actor section. It has been decided 1) to provide a definition of Image Display Actor, 2) to order alphabetically all the definitions of Actors and 3) to edit an open issue related to the specific functionalities required to query/retrieve and display an Anatomic Pathology image (**Person assigned : NF (Aurora), CD (ADICAP**))

CP5: change "PWF" into "APW", change "Pathology Workflow" into "Anatomic Pathology Workflow". Accepted by everybody. (**Person assigned : CD (ADICAP**))

CP6: wrong definition of Acquisition Modality. Accepted by everybody. (**Person assigned : MG (SEAP**))

CP7: Option "Report Image For Order Group" in transaction PAT-3. Everybody agreed to define the PAT-3 as close as possible to the transaction used in the Laboratory domain to send the lab reports to the Result Tracker.

The Order Placer should request this service to the Order Filler.

It has been accepted to restrict the form to pdf only. Other pdf format were discussed (tagged pdf, pdf/a).

The solution adopted by Castilla de la Mancha is close to RID profile (out of the scope of this first TF)

#### Two new CP will be edited to be discussed in Evora

- CP8 : CP including the minor changes sent previously by mail by MG
- CP9: Query Modality Worklist (JK (Tribvn), CD (ADICAP), GR (Satec)). CP providing use cases for querying modality worklists and changes into the query/matching/display keys tables.
