**I. Reports & Updates**

- a. Managed Delivery Workflow
  - One comment received in Public Comment period
- b. Other Issues Raised
  - Question (Mr. Beifuss) regarding to trade-off between specific requirements for 2008 Connectathon and more general requirements for clinical applications.
  - Explicit support for resumption after interrupted treatment.
- c. Canceled Procedure Step
  - Use > 0% and <100% completion to indicate that procedure was started, but not completed.
  - Decision not to support query for ALL CANCELED PROCEDURES in TMS.
  - Question raised regarding the transient existence of UPS messages.
  - What is the mechanism for re-scheduling the procedure step?
- d. Review of Dr. Murray Updates in Document
  - Correction of diagram for integrated delivery
  - Delivery interruption issues
    - Interrupted procedure step is in CANCELED state.
    - Information to be provided to TDS for a treatment completion?  
Consensus: original Plan + Treatment Record (i.e., we should not require a new “completion” plan)
    - How to flag a “completion” request? Include “CONTINUATION” code in Scheduled Processing Parameters Sequence, and supply UUIDs of RT Plan, RT Treatment Record, and RT Treatment Summary instances.
  - Dr. Murray will update the new changes on the T-Con scheduled for December 6<sup>th</sup>.
- e. Multimodality Registration
  - Mr. Johnson informed the committee that there are too many attributes in the tables at the end of Registration Profile. Review and suggested deletions.
