Mission Statement: The American Association of Physicists in Medicine American Society for Radiology Oncology (AAPM) supports a multi-society Task Force to undertake an initiative to promote the Integration of the Healthcare Enterprise (IHE) — Radiation Oncology (RO), fostering seamless connectivity and integration of radiotherapy equipment and the patient health information systems. The Task Force will include members from ASTRO, RSNA, AAPM, the American College of Radiology (ACR) and the Medical Imaging and Technology Alliance (MITA).
